Jarnail Singh & others. The DPC shall be subject to final adjudication by the Hon'ble Supreme court in the case of Jarnail Singh &Ors Vs. Lachhmi Narain Gupta & Ors. in SLP (c) no. 30621 of 2011.

5. Further, the eligibility list is subject to any review later for any contingency like number of vacancies, fixation of seniority, change in recruitment rules etc. and/or direction of any Court/CBDT/DOPT.
