A large number of issues bordering on economic offence and financial fraud are being referred to CBI by different Central Authorities. Many of these are under active investigation while some others are being considered for investigation.

2. CBI is predominantly manned by officers on deputation from different organizations. Presently, we are facing a massive shortage of almost 30% in the strength of officers in the investigative ranks i.e. Inspector of Police. This is severely hampering our ability to take on further caseload as the present officers are already overwhelmed with investigation work.

3. Deputation of officers from other organizations in CBI not only enriches deputationists and widens their horizons but also benefits both the organizations by sharing of best practices.

4. As per the prevailing Recruitment Rules, the eligibility conditions for Inspector (Level-8) in CBI are as follows:-

- The Officer must be a graduate from a recognized university;
- Inspector of Central Excise and Customs or Preventive Officers Grade-I or Examiner in Customs Office or Income Tax Inspectors or persons working in the analogous post on regular basis under the Central Government or State Government or Central Public Sector Undertaking with at least five years' Executive experience in vigilance or investigation or intelligence work.

5. The officers on deputation to CBI are entitled for Special Incentive Allowance of 20% of basic pay every month. Nominated officers must have high level of integrity and impeccable service record.

6. I shall be grateful if you could kindly sponsor a panel of 05 willing and eligible officers for consideration of their induction in CBI as Inspector, on deputation basis, for an initial period of 05 years.

7. It is needless to mention here that such deputation will enable large number of officers to gain extensive experience of conducting critical investigations in the premier organization and help create a pool of sufficiently skilled and expert officers, which will further strengthen the resources of lending Institution.
