2. In this matter it is apprised that Hon'ble Supreme Court vide its decision dated 18.07.2023, in a contempt petition (Civil) No. 873/2023 filed by Sh. S.S. Sundaram against Department of Revenue, has directed of giving benefit of reservation in promotion on notional basis to all eligible PwBDs up to the lowest rung of Group 'A' w.e.f. 30.06.2016. Accordingly, the DoPT vide its OM No. 36012/1/2020-Estt (Res-II) dated 28<sup>th</sup> December 2023 has directed to extend benefit to eligible PwBDs w.e.f. 30.06.2016 after holding review DPC as per extent instructions issued by the DoPT in this matter.
