Jarnail Singh & others. The DPC shall be subject to final adjudication by the Hon'ble Supreme court in the case of Jarnail Singh &Ors Vs. Lachhmi Narain Gupta & Ors. in SLP (c) no. 30621 of 2011.
- 5. Further, the eligibility list is subject to any review later for any contingency like number of vacancies, fixation of seniority, change in recruitment rules etc. and/or direction of any Court/CBDT/DOPT.
