Subject: Settlement of outstanding mobile phone bills issued under 'Project Tarang'—

2. MTNL has finalized the proposal for Settlement of outstanding mobile phone bills issued under 'Project Tarang'. The key points of the settlement scheme are as under:-

- i. A rebate of 65 % on the basis of percentage of total outstanding amount over and above the monthly charges for the entire period till 2018-19 **excluding Service tax & GST** has been approved by MTNL authorities. This rebate is not applicable on the outstanding amounts after 31 March 2019.
- ii. Time period up to 31st March 2024, has been allowed by MTNL authorities to pay the outstanding amount.
- iii. MTNL has shared the payable amount after giving rebate of 65% on the outstanding amount (upto March, 2019) to all respective subscribers through SMS.
- iv. The payment of the outstanding dues can be made through following modes :
 - a. MTNL NCR counters.
 - b. MTNL website **MTNLDELHI.IN**
 - c. PayTm App
 - d. Cheques in favour of **MTNL Delhi Dolphin** may also be deposited at banking unit (Room No. 751, Kidwai Bhawan, Janpath, New Delhi).

3. Once the requisite payment is made by the officer/official, the payment details may be shared with MTNL on email ID CSCIDGAH1@GMAIL.COM

4. Keeping in view the above key points, all the officers and officials of the Income-tax department under Delhi region/CBDT (both serving & retired) may avail this opportunity and make payments with respect to their mobile numbers within the timelines, i.e., upto 31st March, 2024.

5. It is reiterated that all the subscribers have been communicated their outstanding amounts after approved rebate (upto March, 2019) by MTNL through SMS. The subscribers who have not yet received any communication from MTNL may contact O/o the Nodal Officer Delhi 'Project Tarang' at Room Number 151A, 1st Floor, C. R. Building, I. P. 
