### A. Terms and Conditions

### 1. The Reserve Price of waste scrap is as under:-

- 2. The vendor has to lift the record in scheduled time; failure to do so may result in forfeiture of deposited amount
- 3. The removal and loading of waste shall be handled by vendor and concerned transport charges will be borne by vendor only.
- 5. The necessary transport permission shall be the responsibility of vendor.
- 6. The tender shall be submitted in the format as Annexure A.

# B. General Terms and Conditions and General Information:

- 1. The bidder should be registered with Central/State Pollution Control Board and should have the valid license in case of e-Waste materials. A copy of the License should be enclosed along with the offer. Non-submission of a valid license will render the tender as invalid and will be rejected.
- 2. Quotations are to be submitted in sealed covers in the prescribed proforma as Annexure-II super subscribing the details of quotation and should be submitted within the last date and time specified above.
- 3. GST/TDS/TCS to be paid extra, as applicable, at the time of taking out the materials.
- 4. The sale be on "AS IS WHERE BASIS IS" (Both Lot wise and Item wise) bidders will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quality of the articles/items proposed to be auctioned.
- 5. It is responsibility of the bidder to assess the items properly before quoting. No further claims will be entertained after opening of the bids.
- 6. Bid received within the due date only will be entertained.
- 7. The quotation should be valid for a period of 60 days for acceptance from the date of opening of the bid.
- 8. The quotation shall be written legibly and be free from erasing and over-writing. Corrections, if any, should be duly attested by the authorized signatory. Rates should be written both in words and in figures.
- 9. Bidder cannot withdraw their offer once it is submitted.
- 10. No enquiry of the bidder shall be entertained once the material is lifted by them.
- 11. All labour, tools and equipments for loading the items from the O/o JCIT, VU-1(3), Gurugram stationed at Ambala site to buyer's trucks/vehicles with all leads, lifts etc., shall be at the cost of the buyer.
- 12. The intending bidder have to deposit participating fee of Rs.200/-(Non refundable) by the way of Demand Draft payable at State Bank of India, Panchkula in favour of "ZAO' CBDT" payable at Panchkula before participating in the auction.
- 13. The successful bidder with Highest Bid will be issued a Sale Order and shall have to make online payment in Bharat Kosh.
- 14. The quantity of the items indicated in the list is approximate and sale will be effected at actual at the time of taking delivery.

- 20. The bidders are required to indicate their PAN in their offer since it has been made mandatory by the Income Tax Department.
