- 2. The functions of the Taxpayers' Charter Cell shall be to act as nodal office at the field level for:
 - i. Implementation & compliance of the Taxpayers' Charter.

- ii. Handling all the issues related to Taxpayers' Charter & grievances in the form of e-Nivaran/CPGRAMs.
- iii. Monitoring the standards for service delivery as decided & published by CBDT/Directorate of O&MS/Systems from time to time.
- iv. To provide a fair & impartial system to the taxpayers & monitor to resolve their tax issues in a time-bound manner.
- v. Provide a fix time window daily for any taxpayer having any grievance to meet the officers in the cell without prior appointment.
- vi. Co-ordinate all matters relating to issues regarding redressal of grievances/complaints pertaining to Taxpayers' Charter Cells with the Directorate of Tax Payer Services-I (TPS-I), which shall be the designated nodal point of CBDT for overall monitoring of the Cells at the field level.
- vii. Submit a monthly report in a prescribed format to Directorate of Tax Payer Services-I (TPS-I) by 10th of every month.

Taxpayers are hereby informed that any taxpayer having grievance can meet any of the above mentioned officers regarding their grievance without any prior appointment on any working day (except pubic holidays) between 3PM to 4PM.
