TENDER NOTICE FOR HIRING OF UNSKILLED/SKILLED WORKFORCE THROUGH SERVICE PROVIDER

Tenders are invited from the reputed well established and financially sound Manpower Company/Firm/Agency for providing manpower to perform unskilled/skilled jobs on contract basis, to be engaged in the office of Commissioner of Income Tax (TDS)-1, Chandigarh.

The tender documents alongwith the instructions and terms and conditions can be downloaded from the Department's web site www.incometaxchandigarh.org. The prospective bidders are advised to check the eligibility criteria thoroughly before applying for the Tender.

The tenderer should apply through offline mode only. No other mode of application for tender will be entertained. The offline bids can be submitted by Registered Post or by-hand in sealed envelopes in the office of the Commissioner of Income Tax (TDS)-1, Chandigarh by 16.07.2021 till 03:00 P.M. The Technical bids will be opened on 19.07.2021 at 03:00 P.M. in the presence of Addl. Commissioner of Income Tax (TDS), Chandigarh. Financial bids of technically qualified, eligible bidders meeting all the requisite criteria only shall be opened on 19.07.2021 at 04:00 P.M.

The decision upon the bids received shall be taken upon by the Competent Authority on 22.07.2021 and the same will be communicated to the bidders. This office reserves the right to amend/withdraw any of the terms and conditions in the Tender Documents or to reject any or all tenders without giving any notice or assigning any reasons. The decision of the Commissioner of Income Tax (TDS)-1, Chandigarh in this regard shall be final and binding on all.

Interested agencies shall send sealed bids (two separate sealed envelopes super-scribing "Technical Bid" and "Financial Bid" enclosed in big single envelope for providing manpower to perform skilled/unskilled jobs) in the manner specified in the tender document to the office of Commissioner of Income Tax (TDS)-1, Chandigarh. It is further stated that the terms and conditions of the tender can be downloaded from the www.incometaxchandigarh.org.

1. General Instructions for Tenderers

- (i) The office of the Commissioner of Income Tax (TDS)-1, Chandigarh requires the services of a reputed well established and financially sound Manpower Company/Firm/ Agency for providing manpower to perform unskilled/skilled jobs (The no. of persons required may vary as per requirement).
- (ii) The initial requirement is for 12 Data Entry Operators & 10 unskilled Multi Functional workers to perform their jobs (which include 1 Mali, 1 Sweeper, 4 Peons and 4 Security Guards without arms) but the no. of persons, unskilled and skilled, may increase or decrease as per the requirement of the office.
- (iii) The contract is likely to commence from the date of acceptance and would continue for a period of one year. the period of the contract may be further extended after the completion of contract, provided the requirement of this office for augmenting its present manpower persists at that time or may be curtailed / terminated before the contract period owing to deficiency in service or substandard quality of manpower deployed by the selected Company/Firm/Agency or induction of regular manpower in this office. This office however, reserves right to terminate the initial contract at any time after giving one week's notice to the selected service providing Company/Firm/Agency.
- (iv) The service provider is responsible for payment of monthly salary including leave salary, bonus, gratuity etc. to the hired personnel as applicable to them under law. The Service provider should ensure that salaries are paid on time every month. It is mandatory for the service provider to pay the prevailing wages prescribed by the Minimum Wages Act, of the U.T. Government to the manpower.

2. <u>Eligibility of the hired personnel:</u>

Age: 18-40 years

Educational Qualification:

- (i) Minimum 10th Pass for Un-skilled.
- (ii) Graduate for skilled and they should be well versed in Hindi and English & numeric system.

Personnel under both the category should be physically fit and of sound health.

It is essential that the antecedents of the workers/manpower are verified by the manpower agency from the local police authorities and the agency should certify the moral character of the workers alongwith a certificate ensuring that there is no police record for each of the persons. The persons preferably should be stationed / resident of Chandigarh, Panchkula District or Mohali District.

- (i) The interested Company/Firm/Agency may submit the tender document, along with Earnest Money Deposit of Rs.10,000/- in favour of the ZAO, CBDT, Chandigarh and other requisite documents. The DD should be sent manually to the O/o Commissioner of Income Tax (TDS)-1, 2nd Floor, Income Tax Wing, Central Revenue Building, Sector 17-E, Chandigarh -160017.
- (ii) The tenders have been invited under two bid system i.e. Technical Bid and Financial Bid. The interested Agencies are advised to submit two separate bids viz. "Technical Bid" and "Financial Bid" enclosed in one single envelope for providing manpower to perform the skilled/unskilled jobs in the office of the Commissioner of Income Tax (TDS)-1, Chandigarh.
- (iii) The tendering Company/Firm/Agency is required to enclose following documents, duly attested, along with the Technical Bid, failing which their bids shall be summarily rejected and will not be considered any further:
 - 1. PAN/GIR No. (Attach attested copy)
 - 2. GST No. (Attach attested copy)
 - 3. E.S.I. Registration No. (Attach attested copy)
 - 4. Documents showing completing at least one service of value not less than Rs. 25 Lakh per annum or at least two services of value not less than Rs.15 Lakh per annum related to providing human resources in a single contract. (in original)
 - 5. <u>Details of the major similar contracts handled by the tendering</u> Company/Firm/Agency on behalf of PSUs and Government Departments <u>during</u> the last two years. (Attach attested copy)
 - 6. Affidavit worth Rs.100/- stating that the agency is/has not been black listed by Centre/ State Government/ PSU (Attach attested copy)
 - 7. Number of similar assignments; Manpower provided to public/ private/ PSU in last 5 years by the Agency (Attach attested copy)
 - 8. Certified document in support of financial turnover of the agency for the last three years.
- (iv) Conditional bids shall not be considered and will be rejected at the very first instance.
- (v) The Technical Bid shall be opened first on the scheduled date and time, in the chamber of Addl. Commissioner of Income Tax (TDS), Chandigarh in the presence of the representatives of the Company/Firm/Agency, if any, who wish to be present on the spot at that time. The Technical Bids shall be evaluated by the Local Purchase Committee, and Tender Committee O/ o the Commissioner of Income Tax (TDS)-1, Chandigarh. Financial bids of technically qualified, eligible bidders meeting all the requisite criteria only shall be opened later in presence of the short listed contractors or their authorized representatives.
- (vi) The competent authority of Office of the Commissioner of Income Tax (TDS)-1, Chandigarh, reserves the right to annul any or all bids without assigning any reason.

- (vii) The bidder shall submit the technical & financial bids in the office of the Commissioner of Income Tax (TDS)-1, Chandigarh as per the format enclosed at Annexure I & II. In addition, the bidder may send the bids in two separate sealed envelopes enclosed in one big envelope super-scribing "Technical Bid" for providing manpower to perform the skilled/ unskilled jobs to the office of the Commissioner of Income Tax (TDS)-1, Central Revenue Building, Sector 17-E Chandigarh and "Financial Bid" for providing manpower to perform skilled/ unskilled jobs in the office of the Commissioner of Income Tax (TDS)-1, Central Revenue Building, Sector 17-E Chandigarh. Both the sealed envelopes should be kept in a third big sealed envelope super-scribing "Tender for providing manpower to perform jobs in the office of the Commissioner of Income Tax (TDS)-1, Chandigarh
- (viii) In case of any discrepancy between the bids submitted by a party through offline mode, the decision of the Commissioner of Income Tax (TDS)-1, Chandigarh is final.

II. TECHNICAL REQUIREMNTS FOR THE TENDERING COMPANY / FIRM / AGENCY

The tendering Service Provider Company/Firm/Agency should fulfill the following technical specifications:

- 1. The Registered Office or one of the Branch Offices of the Service Provider Company/ Firm/ Agency should be located within the Chandigarh/ Mohali/ Panchkula.
- 2. The Service Provider Company /Firm/Agency should be registered with the appropriate registration authority.
- 3. Service Provider Company/Firm/Agency should have at least five years experience in providing manpower to private and/or public sector Company/Banks and Government Departments etc.
- 4. Service Provider Company / Firm / Agency should have its own Bank Account.
- 5. Service Provider Company/ Firm/ Agency should exist on the records of Income Tax and GST Deparetments.
- 6. Service Provider Company/Firm/Agency should be registered with appropriate authorities under Employees State Insurance Acts.
- 7. The Service Provider Company/Firm/Agency should have completed at least one service contract of value not less than Rs.25 lakh per annum or completed at least two service contracts of value not less than Rs.15 lakh per annum related to providing human resources in a single contract.

- 8. The Service Provider Company /Firm/Agency must have a turnover of Rs.50 lakh per year during the last three financial years.
- 9. The Service Provider Company / Firm / Agency shall submit affidavit stating that the agency is/has not been black listed by Central Government / State Government / any PSU.

Non compliance with any of the above conditions by the Service Provider Company / Firm / Agency will amount to non-eligibility for the services for which tender has been floated and its tender will be ignored summarily.

III. TERMS AND CONDITIONS

A. General

- (i) The contract is likely to commence from the date of acceptance and shall continue for a period of one year, unless it is curtailed or terminated by this Office owing to deficiency of service, sub-standard quality of Personnel deployed, breach of contract, reduction or cessation of the requirements of work, insubordination and dereliction of duty.
- (ii) The contract shall automatically expire after one year from commencement of the contract unless extended further by the mutual consent of contracting Agency and this Office.
- (iii) The contract may be extended, on the same terms and conditions or with some addition/deletion/modification for a further period not exceeding one year at the sole discretion of O/o Commissioner of Income Tax (TDS)-1, Chandigarh.
- (iv) The contracting Company /Firm/Agency will be required to pay minimum wages as prescribed. The contracting agency will maintain proper records as required under the Law/Acts. It shall be the duty of the contracting company/ agency to enhance the wages of the employees subject to any statutory obligation/raise from time to time as instructed by authorities concerned in this behalf. However such statuary enhancement shall be claimed from the department by the contracting agency on furnishing documentary proof of payment of such amount to it employees and this enhancement/raise shall be deemed to be agreed upon between the department and contracting agency/company.
- (v) The requirement of this office may further increase or decrease during the period of contract and the contracting agency would have to provide additional Attendants, if required, on the same terms and conditions.
- (vi) The contracting Company/Firm/Agency shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other Agency without the prior written consent of this Office.
- (vii) The tenderer will be bound by the details furnished by it to this Office, while submitting the tender or at any subsequent stage. In case any of the documents furnished by it is found to be false at any stage, it would be deemed to be a breach of terms of contract, making the tenderer liable for legal action besides the termination/ cancellation of contract, legal action for damages at the sole

discretion of O/o Commissioner of Income Tax (TDS)-1, Chandigarh. And in such eventuality, the security amount tendered shall be liable to be forfeited. (viii) Financial bids of only those tenderers who are declared qualified technically shall

- be evaluated.
- The Office of the Commissioner of Income Tax (TDS)-1, Sector 17-E, Chandigarh (ix) reserves the right to terminate the contract at any time or without giving any notice.
- The contracting Agency shall ensure that the manpower deployed in the Office of (x) the Commissioner of Income Tax (TDS)-1, Central Revenue Building, Sector 17-E, Chandigarh conforms to the eligibility conditions of age, education and any other qualification as specified in the contract.
- The manpower employed by the Agency shall be required to work as per the office (xi) working timings, i.e. from Monday to Friday from 0930hrs to 1800hrs with a lunch break of half hour from 1330 hrs to 1400 hrs. At times, the deployed manpower may be required to work on Saturdays, Sundays, Gazetted Holidays and beyond normal office hours on working days.
- The successful contracting Company/Firm/Agency shall furnish the following (xii) documents in respect of the persons who will be deployed by it in this Department before the commencement of work.
 - a) List of persons shortlisted by Agency for deployment in the Office of the Commissioner of Income Tax (TDS)-1, Central Revenue Building, Sector 17-E Chandigarh containing full details i.e. date of birth, marital status, address, educational and professional qualification, experience etc.

b) Bio-data of the person with photograph affixed.

- c) Character certificate from a Gazetted officer of the Central / State Government.
- d) Certificate of verification of antecedents of persons by local police authority.
- (xiii) In case, the person employed by the successful Company/Firm/Agency performs any act of omission/ commission that amounts to misconduct/ indiscipline/ incompetence and security risks, the successful Company/Firm/Agency will be liable to take appropriate disciplinary action against such persons, including their removal from site of work, if required by the Office immediately after being brought to their notice.
- The service provider shall provide identity cards to the personnel deployed in the (xiv) Office carrying the photograph of the personnel and personal information including name, date of birth, designation and identification mark etc.
- The service provider shall ensure that any details of office, operational process, technical know-how, security arrangements, and administrative/organizational matters are not divulged or disclosed to any person by its personnel deployed in the Office.
- The service provider shall ensure proper conduct of its personnel in office premises, maintain strict discipline in and around the office premises and enforce

prohibition of consumption of alcoholic drinks, chewing pan, smoking, loitering without work etc. or consuming any other intoxicant substance, food or drink during the work hours/ being on duty to maintain discipline and office decorum.

- (xvii) The Agency shall depute a coordinator, out of the deployed personnel, who would be responsible for immediate interaction with the Office of the Commissioner of Income Tax (TDS-1), Chandigarh so that optimal services of the persons deployed by the agency could be availed without any disruption. However the office of the Commissioner of Income Tax (TDS-1), Chandigarh shall be fully competent and empowered to remove any indisciplined personnel/staff from its premises if his/her behaviour is not upto the mark, immoral and / or his /her presence is prejudicial/ embarrassing to the department.
- (xviii) The selected Agency shall immediately provide a substitute in the event of any person leaving the job due to his/ her personal reasons. The delay by the Agency in providing a substitute beyond three working days shall attract liquidated damages @ Rs. 100 per day (per such case) on the service providing Agency, besides deduction in payment on pro- rata basis.
- (xix) It will be the responsibility of the service providing Agency to meet transportation, food, medical and any other requirements in respect of the persons deployed by it (Agency) in this Office and this Office will have no liabilities in this regard.
- (xx) For all intents and purposes, the service providing Agency shall be the "Employer" within the meaning of different Labour Legislations in respect of manpower so employed and deployed in this Office. The persons deployed by the Agency in the Office shall not have claims of any Master and Servant relationship nor have any principal and agent relationship with or against the Office of the Commissioner of Income Tax (TDS)-1, Chandigarh.
- (xxi) The service providing Agency shall be solely responsible for the redressal of grievances/resolution of disputes relating to persons deployed. This Office shall, in no way, be responsible for settlement of such issues whatsoever as this office shall have no privities of contract with the work force.
- (xxii) This Office shall not be responsible for any damages, losses, claims, financial or other injury to any person deployed by service providing Agency in the course of their performing the functions/ duties, or for payment towards any compensation.
- (xxiii) The persons deployed by the service providing Agency shall not claim nor shall be entitled to pay, perks and other facilities admissible to casual, ad hoc, regular/ confirmed employees of this Office during the currency or after expiry of the contract. That any issue of pay, perks, statutory obligations, welfare schemes or monetary benefits/internal arrangements of the employees, their personal insurance (If any) shall be looked after by the contracting agency and the department has no interference or liability of any nature in any manner whatsoever.
- (xxiv) In case of termination of this contract on its expiry or otherwise, the persons deployed by the service providing Agency shall not be entitled to and will have no claim, for any absorption nor for any relaxation for absorption in the regular / other capacity. In brief there shall be no privity of contract between the

- department and the individuals/work force provided by the service provider/contracting agency.
- (xxv) The contracting agency should communicate above conditions to all the persons deployed in this office by the contracting agency.
- (xxvi) Payments shall be made only to the contracting agency and on monthly basis as per actual services. The contracting agency has to raise invoices in the first week of the next month for the services rendered in the month.
- (xxvii) The department has right to relax Technical Qualification in case sufficient number of quotations are not received.
- (xxviii)This office reserves the rights to postpone / and / or extend the date of receipt/opening of Rates/Quotations or to withdraw the same, without assigning any reason thereof.
- (xix) The service Provider are required to submit the complete rates/quotations only after satisfying each and every conditions laid down in the terms and conditions.
- (xxx) All the rates must be provided both in figures and words. In case of discrepancy between the words and figures, the rates indicated in figures shall prevail.
- (xxxi) Rates/Quotations should be submitted and signed by the firm with its current business address.

B. <u>LEGAL</u>

- (i) The Service provider shall be responsible for compliance of all statutory provisions relating to Minimum wages, Employees State Insurance, Provident Fund and other labour laws etc. in respect of the persons deployed by it in this Office as this office has no privity of contract with the employees.
- (ii) The Service provider shall also be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to the Office of the Commissioner of Income tax, TDS-1, Central Revenue Building, Sector 17-E, Chandigarh to concerned tax collection authorities from time to time as per extant rules and regulations on the matter.
- (ii) The Service provider shall maintain all statutory registers under the applicable laws. The Agency shall produce the same, on demand, to the concerned authority of this Office or any other authority under Law.
- (iii) The Tax Deduction at Source (T.D.S.) shall be deducted as per the provisions of Income Tax law, as amended from time to time and a certificate to this effect shall be provided to the Agency by this Office.
- (iv) In case, the tendering Agency fails to comply with any statutory/taxation liability under appropriate law and as a result thereof the Office is put to any loss/obligation, monetary or otherwise, the Office will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the Agency, to the extent of the loss or obligation in monetary terms.

C. FINANCIAL

- (i) Bids, offering rates which are lower than the minimum wages (as applicable for the UT, Chandigarh) for the pertinent category, would be rejected.
- (ii) The Agency shall raise the bill, in triplicate, along with attendance sheet to the O/o Commissioner of Income Tax (TDS)-1, Chandigarh under whom the outsourced personnel has been deployed in the first week of the succeeding month. The office will send the bills duly verified to the office ZAO, CBDT, Chandigarh for sanction and payment.
- (iii) The claims in bills regarding Employees State Insurance, Provident Fund, and Service Tax etc. should be necessarily accompanied with documentary proof pertaining to the concerned month bill. A requisite portion of the bill/ whole of the bill amount shall be held up till the proof is furnished, at the discretion of this Office.
- (iv) Settlement of disputes will be as per Indian Arbitration and Conciliation Act-1996 and venue will be the Office of the Commissioner of Income Tax, TDS-1, Central Revenue Building, Sector 17-E, Chandigarh. It is clarified that the sole arbitrator to adjudicate any disputes arising out of the proposed contract shall be nominated/appointed by Commissioner of Income Tax (TDS)-1, Chandigarh.
- (v) The Office of the Commissioner of Income tax, (TDS-1), Chandigarh reserves the right to withdraw/ relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
