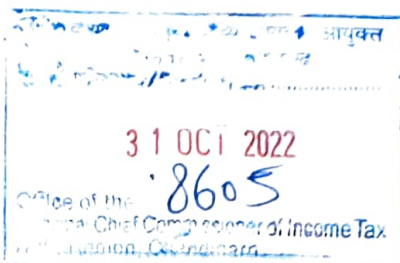

## Terms & Conditions
