

Commissioner of Income-Tax, Patiala invites online bids/quotation in two bid system (Technical Financial) from reputed, experienced and financially sound Manpower companies/Firms/ Agencies engaged in the business of providing House Keeping Services to provide housekeeping services for a period of minimum two years. 

## **I) DATA ENTRY OPERATORS**

**THE FOLLOWING QUALIFICATION SHOULD BE FULFILLED BY THE DATA ENTRY OPERATORS:-**

- a) The personnel should preferably be Graduate with English as one of the subject.
- b) The personnel should have minimum typing speed of 40 wpm in English and same speed in Hindi preferably though not compulsory. Also persons who have shorthand knowledge be preferably deployed.
- c) The person should possess hands on working knowledge of software such as MS Word, MS Excel, MS Power Point etc. Web based networking, Tally and hardware of computer.
- d) The age of personnel should be between 20 years to 35 years.

**NATURE OF DUTIES OF DEOs ARE GIVEN BELOW:-**

- a) Typing on MS Word, preparing reports on MS Excel and preparing presentation on MS Power point.
- b) Taking dictation and drafting and working in word/excel/any other software used in department.
- c) Cleaning and keeping computers, printer, fax machine, copier, scanner or any other office equipments being used by them in good working condition, printing of documents and any other work assigned by the superior authority.
- d) Any other work assigned to them like assistance to regular staff in carrying of files & other papers within the building, physical maintenance of records of the section, General Cleanliness and upkeep of the section/unit, assistance in routine office work like diary, dispatch etc., including on computer, photocopy, sending of FAX etc, other non-clerical work in the section/unit.



## **II) MULTI-TASKING STAFF**

### THE FOLLOWING QUALIFICATION SHOULD BE FULFILLED BY THE MTS:-

- a) The person should have fair knowledge of reading and writing in English, Hindi & Punjabi so that he/she is able to understand files and diary/dispatch work etc.
- b) The age of personnel should be between 20 years to 45 years with preference to younger age group.
- c) The personnel should be able to work till late hours as and when required.
- d) The candidates should be matriculate at least.

### NATURE OF DUTIES OF MTS ARE GIVEN BELOW:

- Delivering of DAK (outside the building).
- Carrying of files & other papers within the building.
- Physical Maintenance of records of the section.
- General Cleanliness and upkeep of the section/unit.
- Assisting in routine office work like diary, dispatch etc., including on computer.
- Photocopy, sending of FAX etc.
- Other non-clerical work in the section/unit.
- Opening and closing of rooms.
- Dusting of furniture etc.
- Cleaning of building, fixture etc.
- At least 02 MTS should be trained cooks and must have experience in maintenance of guest house. They may be deployed for upkeep of guest house.
- 05-07 MTS should be trained in gardening also for upkeep of garden in the office.
- Any other work assigned by the superior authority.

## **III) CHOWKIDAR**

### TERMS AND CONDITIONS

- (a) The personnel should preferably be middle school pass.
- (b) The age of personnel should be between 25 years to 45 years.
- (c) The personnel must be fit and in good health.
- (d) The personnel should preferably be Ex-Servicemen.

### NATURE OF DUTIES OF CHOWKIDAR ARE GIVEN BELOW:-

- (a) Duty to close the office after office hours and to ensure the safety of the office and the Government properties.
- (b) To keep vigil on entry and exit of visitors.
- (c) To attend any other official duties as & when required by



## GENERAL TERMS AND CONDITIONS

1. The normal working hours of the DEOs/MTS will be from 0930 hrs to 1800 hrs, if necessary even on holiday, with ½ hrs lunch time break. The work shall be done on all working days and payment will be made on the basis of attendance. Whenever necessary, DEOs/MTS will be required to work even on Saturday, Sunday or any other holidays, as ordered by controlling officer.
2. The total number of DEOs/MTS/Chowkidar deployed shall be at the sole discretion of this office.
3. The personnel, if not found working satisfactorily, must be replaced by the Service provider immediately.
4. The personnel should be punctual and should complete the work assigned to them promptly and meticulously.
5. The personnel should report to the officer in charge as assigned by this office.
6. The service provider is responsible for payment of monthly wages to the personnel to be engaged by it in compliance of all the statutory obligations under all related and applicable laws to it from time to time including Contract labour Act, Minimum Wages Act, Employees provident Fund, ESI Act, etc. The Service provider should ensure that wages are paid on or before 7<sup>th</sup> of following month irrespective of the fact that the bill for the month is pending for payment. It is mandatory for the service provider to pay the prevailing DC rates or rates approved by this office from time to time whichever is higher. As per current order, the daily rates are Rs.629/- per day for DEO and Rs. 459/- per day for MTS.
7. All existing statutory regulations of Central Government shall be adhered to by the service provider and all records maintained thereof shall be available for scrutiny by this office. Any failure to comply with any of the above regulations or any deficiency in service will render this contract liable for immediate termination without any prior notice.
8. The bill shall be submitted by the Service Provider on or before 7<sup>th</sup> of the following month. At the time of submission of bill for payment, the contract/service provider should submit the proof for the previous payment made towards statutory liabilities. The



wages paid to the personnel. Payments shall be made only to the contracting agency and on monthly basis as per actual services. The contracting agency has to raise invoices in the first week of the next month for the services rendered in this month. The department shall make payment according to the availability of the funds.

9. The persons engaged by the Contracting Agency/Service Provider will be in the employment of the Contracting Agency/Service Provider only. There will not be any employer-employee relationship between the persons deployed by the contractor and the Income-tax Department.
10. The Contractor/Service Provider shall indemnify and keep this office indemnified against all acts of omission, negligence, dishonesty or misconduct of the personnel engaged and this office shall not be liable for any damages or compensation to any personnel or third party.
11. All damages caused by the personnel to the property of the office shall be recovered from the Service Provider.
12. This office reserves the right to extend the contract further, on the same terms and conditions subject to satisfactory performance of the Service Provider.
13. No other person except Service Provider's authorized representative shall be allowed to enter the offices.
14. Department/office will not involve in any dispute between the service provider and workers of the service provider.
15. Aadhar/PAN Numbers of each DEOs/MTS/Chowkidar will be verified by the service provider and they will be allowed to work in this office only after proper police verification. Proper identification card shall be provided by the contractor/bidder to the personnel deployed as DEOs/ MTS/Chowkidar and it must be ensured that the same are worn at work.
16. The contractor/bidder shall ensure that workers deployed by it maintain discipline of the highest order and that they restrict themselves to their assigned work only.
17. Any incidence of inappropriate behavior by any of the DEOs/MTS/Chowkidar will lead to breach of agreement and will be sufficient cause for termination of agreement if such person is not removed immediately.



18. Notwithstanding anything contained herein, this office reserves the right to terminate the services of the Contracting Agency/Service Provider at any time without giving any notice or reasons whatsoever.
19. The contractor will have to issue wearable photo identity cards to its persons & the DEOs/MTS/Chowkidar will be required to display it at all time while in office failing which the person may be asked to leave the premises & penalty of Rs.100/- on each instance of failure will be levied.

**Conditions to be satisfied by the contractor.**

- The Contractor should be resident of Patiala as on date of tender.
- The service provider should have at least 5 years similar experience in any government office and the experience certificate should be attached with technical bid.
- The service provider should have turnover of at least 50 lakh per annum for last three financial years.
- The contractor should be registered for compliance of ESI, EPF and Service Tax Rules and proof of the same needs to be submitted.
- The bidder should have sound financial capacity and minimum capital of Rs.10 lakh as on date of tender in bank account. A proof in the form of bank statement showing such balance must be attached alongwith technical bid.
- Any financial bid containing zero percent commission rate will be rejected to avoid any fictitious bidder.
- It would be the responsibility of the contractor to make alternate arrangements if for some reason workers/staff is not available. In case the manpower is not available, no payment will be made for the day for that person, rather a penalty equivalent to cost per day of manpower will be levied and deducted from the monthly bill.
- The bills have to be submitted along with the acknowledgement/proof of payment. The contractor should also maintain all relevant registers, records and accounts & produce the same to this office as and when required.
- The workers will be paid for only the number of days they have worked.
- In case there are complaints against any DEO/MTS/Chowkidar, he/she should be reprimanded/replaced immediately.
- This office could ask the contractor to increase or reduce workers depending on the need on same terms and conditions.



- Bank Guarantee for an amount of Rs.5 lakh should be provided by the contractor as security.
- No amount other than statutory required deductions like PF, ESI etc. shall be deducted from payment of DEO, MTS and Chowkidar . Any contractor found asking for money in the form of commission or in any other form from data entry operators/typist/peon will be blacklisted and his contract will be terminated. Also, any non-statutory deduction from the payment of DEOs/MTS/Chowkidar will lead to termination of contract.
- The Contractor shall ensure proper conduct of his personnel in office premises and enforce prohibition of consumption of alcoholic drinks, paan and smoking, loitering without work.

**Points to Remember:-**

1. The bidders are required to submit two bids, i.e. Technical bid and financial bids, in the prescribed formats. In the technical bid, the bidder will provide details about his experience in the field, detail of other organizations for which he is providing such services, details regarding compliance of statutory laws etc. In the Financial bid, the bidder will submit the quotation for his charges. The service providers will be shortlisted on the basis of their technical competency after opening of technical bids. Financial bids of only those bidders, who are shortlisted on the basis of Technical bid will be opened and the bid with lowest quotation among the opened bids will normally be approved.
2. The department has right to relax Technical Qualification in case sufficient number of quotations are not received.
3. This office reserves the right to postpone and /or extend the date of receipt/opening of bids/Quotations or to withdraw the same, without assigning any reason thereof.
4. The service provider are required to submit the complete rates/Quotations only after satisfying each and every condition laid down in the terms and conditions.
5. All the rates must be written both in figures and in words.
6. Rates/Quotations should be submitted and signed under the seal by the firm with its current business address.
7. The contractor/service provider shall sign and stamp each page of the tender document and all other enclosures appended to it as a



- proof of having read and understood the terms and conditions contained herein and submit the same along with Technical Bid.
8. The contractor/Service provider must comply with the rates/quotations, specification and all terms and conditions of contract. No deviation in the terms and conditions of the contract shall be entertained unless specifically mentioned by the service provider in the rates/quotations and accepted by the department.
  9. Bids received later than the stipulated date and time will not be considered under any circumstances. This office reserves the right to reject any tender, even the lowest one without assigning any reasons thereof.
  10. The interested Company/Firm/Agency may submit tender fee in the form of Demand draft of Rs.1000/-and Earnest Money Deposit of Rs.10,000/- in the favour of the ZAO, Patiala. The Demand draft should be submitted to Income Tax Officer, HQ (Admn.),1<sup>st</sup> Floor, Aayakar Bhawan, Patiala. Qualifying bids without tender fee and EMD will be rejected, EMD will be returned to all the unsuccessful bidders at the end of the selection process. However, the EMD shall be forfeited in case the successful bidders who withdraw or the details furnished in Technical and Financial Bid are found to be incorrect and false during the tender selection process. No interest shall be paid on the EMD.
  11. **For any clarification in the matter, prior appointment may be made with Income Tax Officer, HQ (Admn.), O/o The Pr. Commissioner of Income Tax, Aayakar Bhawan, Patiala. (Mob. No. 9530796400)**
  12. In case any successful bidder is found paying lesser than minimum wages, defaulters of EPF/ESI/IT/Labour Laws, his contract will be terminated and the bidder will be blacklisted.

#### **TECHNICAL CONDITIONS.**

1. The contractor/bidder should be registered with the appropriate registration authority with regard to providing manpower to the Government offices i.e. State/Union Territory's Labour Department (Enclose copy of registration certificate of Labour License).
2. The contractor/bidder should have at least five years experience in providing similar services to Government Department.(Enclose documentary evidence).
3. The contractor/bidder should have valid service tax registration/ GST and PAN/TAN which is to be quoted in the sealed quotation and



4. The contractor/bidder should be registered with ESIC & EPF authorities and the attested copies of proof thereof should be provided alongwith the technical bid.
5. The annual turnover of the service provider/Contractor should not be less than Rs.50 lakh for each of last three Financial Years i.e. 2016-17, 2017-18 and 2018-19 and a certified copy of balance sheet and profit and loss account must be enclosed as proof.
6. The Service Provider/contractor must submit copy of Income Tax Returns for A.Y. 2017-18, 2018-19 and 2019-20.

### **FINANCIAL CONDITIONS**

1. The contractor will have to specify the amount to be charged by it towards Service charges/commission for providing the DEO/MTS. It may be noted that in order to eliminate frivolous bids, disguised charges/deduction from wages of personnel, service providers bidding at 0% commission shall be disqualified.
2. In case of multiple bidders quoting same rates, the competent authority will decide the allocation based upon the capital position and past contract experience with own or other Government departments.

Both the bids i.e. Technical and Financial should be in English only and prices should be written/quoted both in figures and in words. In case there is difference in rates quoted by a tenderer in figures as well as in words, the quoted rates in words shall only be considered for evaluation and other purposes.
- (b) The tenderer should ensure that all the scanned copies required to be uploaded online should be original/true copies of documents which are duly attested/sealed and signed.
- (c) The prospective tenderer should ensure that the documents uploaded on the e-portal are clearly typed & scanned and should be legible.
- (d) Tender(s) received beyond the last date of submission shall be summarily rejected and no claim of tenderer shall be entertained in respect of receipt of tenders at a later stage. No tender will be entertained by E-mail or FAX.
- (e) The Income tax department reserves the right to cancel/postpone the tender/contract procedure without assigning any reasons thereof.


## **OPENING OF BIDS:**

## **INSTRUCTIONS FOR ONLINE BID SUBMISSION**

(On Tenderwizard Portal)

The bidders are required to submit soft copies of their bids electronically on the Tenderwizard Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the Tenderwizard Portal, prepare their bids in accordance with the requirements and submitting their bids online on the Tenderwizard Portal. More information useful for submitting online bids on the CPP Portal may be obtained at [www.tenderwizard.com/INCOMETAX](http://www.tenderwizard.com/INCOMETAX).

### **REGISTRATION:**

- 1) Bidders are required to enroll on the e-procurement module of the Public Procurement Portal (URL: [Https://www.tenderwizard.com/INCOMETAX](https://www.tenderwizard.com/INCOMETAX)) with clicking on the link "Online bidder registration" on the Tenderwizard Portal by paying the requisite Registration fee.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidder.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate(Only Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify/TCS/nCode/eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC to others which may lead to its misuse.
- 6) Bidders then log in to the site through the secured log-in by entering their user ID/password and the password of the DSC/e-Token.
- 7) The scanned copies of all original documents should be uploaded on portal.

### **SEARCHING FOR TENDER DOCUMENTS:**

- 1) There are various search options built in the Tenderwizard Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender No, Departmental Name, Place, Date, Estimate Cost, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Department Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the Tenderwizard Portal.
- 2) Once the bidders have selected the tenders they are interested in, they can pay the form fee by DD only and processing fee (NOT REFUNDABLE) by net-banking/ Debit/Credit card. Then they may download the required documents/tender schedules, Bid documents etc. Once they pay both fee, tenders will be moved to the respective



the bidders through SMS/e-mail in case there is any corrigendum issued to the tender document.

#### **PREPARATION OF BIDS:**

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents-including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should be ready with the bid documents to be submitted as indicated in the tender document/schedule and they should be in RAR/DWF/JPEG formats. Bid Original documents may be scanned with 100 dpi with coloured option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading-the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "documents Library" available to them to upload such documents. These documents may be directly submitted from the "Documents Library" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### **SUBMISSION OF BIDS.**

1. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
3. Bidder has to select the payment option as "DD" to pay the tender fee/ EMD as applicable and enter details of the instrument.
4. Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument physically sent, should tally with the details available in the scanned copy and the data entered during bid submission



5. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
6. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
7. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers' public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
8. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
9. Upon the successful and timely submission of bids click "Submit tender"(i.e. after Clicking "Upload Bid and submit tender" in the portal), the portal will give a successful Tender submission acknowledgement. A bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
10. The tender summary has to be printed and kept as an acknowledgement of the submission of the tender. This acknowledgement may be used as an entry pass for any bid opening meetings.
