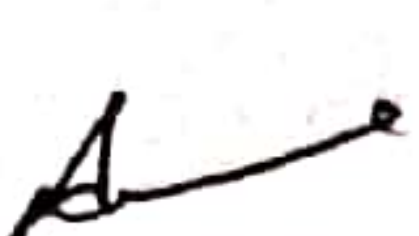

2. In this regard, it is submitted that the generator in the office of Joint Commissioner of Income Tax, Khanna is not working since more than 1 & 1/2 months and needs repair.
3. A purchase Committee for procurement of Goods or Services exceeding Rs. 25,000/- on GeM portal by e-tendering/e-publishing Method for the office of Addl./Joint Commissioner of Income Tax, AU-1(4), Jammu at Khanna was constituted on 21.02.2013 vide Office Order F.No. JCIT, AU-1(4)/Jmu.Hq.Khanna/2022-23/397.
4. A letter by the office of Addl./Joint Commissioner of Income Tax, AU-1(4), Jammu at Khanna bearing No. 398 dated 27.02.2023 was written to the Worthy Pr. Commissioner of Income Tax, AU-1, Jammu seeking administrative approval for repair/service of Generator by e-tendering/e-publishing method, as the repair/service of generator is not available on GeM Portal. The Pr. CIT, AU-1, Jammu informed vide her office letter no. 1683 dated 10.03.2023 that the repair/service of the Generator should be as per GFR, 2017 Rule-166 Single Tender Enquiry.
5. The meeting of the purchase committee was held and it was decided that for repair/service of the generator a quotation is mandatory to be floated on the website www.incometaxchandigarh.org and www.incometax.gov.in as the repair/service of the generator is not available on GeM Portal.
6. It is further requested that the genuine/original parts should be used while repairing the Generator.
