	a) The Manpower Agency should have an experience of not less than five years for supply of such

	 b) It should be registered with the concerned Government Authority and a copy of the document/certificate should be attached with the Technical bid. c) It should have PAN and Service Tax Registration Number. В.	The second sealed envelope super scribed as "Financial Bid", should contain only rates for supply of 01 Data Entry Operators, 01 MTS cum Peon and 01 Sweeper on monthly basis for normal duty of 8 hours per day (excluding lunch of half hour) per person for five days a week (Annexure-III).
C.	Both the sealed covers should be placed in the main sealed envelope super scribed "tender for supply of 01 Data Entry Operators, 01 MTS and 01 sweeper. This should be addressed to the Asstt. 9.	The technical bids will be opened by the purchase committee at 03:00 P.M on 17.10.2020 in the Office of Asstt. Director of Income Tax(I&CI), Gurugram in the presence of one member of each participating bidder, who may like to be present. The technical evaluation committee will assesses the ability of agencies to supply requisite number of personnel in different category based on its record, profile and on such others criteria as it may fix and only those found fit will be eligible for financial bid opening. The financial bids shall be opened immediately after announcement of successful candidate at the stage of evaluation of technical bids.

TERMS AND CONDITIONS

- 1. All services shall be performed by persons qualified and skilled in performing such services as per the eligibility criteria indicated for the category.
- The persons supplied by the Agency should not have any adverse Police records/criminal cases against them. The agency should make adequate enquiries about the character and antecedents of the person whom they are recommending. The character and antecedents before their deployment after investigation by the local police, collecting proof of residence and recent photograph and a certification to this effect submitted to the (Daily wages) employee at the time of initial engagement.
- 3. The service provider will also ensure that the personnel deployed are medically fit and will keep in record a certificate of their medical fitness.
- 4. The Service Provider shall withdraw such employees who are not found suitable by the Asstt. Director of Income Tax (I&Cl), Gurugram for any reasons immediately onreceipt of such a request from the Asstt. Director of Income Tax (I&Cl), Gurugram.
- 5. The service provider shall engage necessary persons as required by this Directorate from time to time. The said persons engaged by the service provider shall be the employees of the service provider and it shall be the duty of the service provider to pay their salary every month through ECS and provide a proof of doing so to the Directorate. The Company/Firm Agency will provide proof of receipt of wages by the workers before the end of each month. There is no Master & Servant relationship between the employees of the service provider and the Asstt. Director of Income Tax (I&CI), Gurugram and further that the said persons of the service provider shall not claim any absorption in the Asstt. Director of Income Tax (I&CI), Gurugram, on any ground whatsoever.
- 6. The service provider's personnel's shall not. Claim any benefit/compensation/absorption/regularization of services from/ in Asstt. Director of Income Tax (I&CI). Gurugram under the provision of Industrial Disputes Act. 1947 or Contract Labour (Regulation & Abolition) Act, 1970. Undertaking front the persons to this effect shall be submitted by the service provider to the Asstt. Director of Income Tax (I&CI), Gurugram
- 7. The service providers personnel shall not divulge or disclose to any person, any details of office, operational process, technical know-how, security arrangements, administrative/organisational matters as all these matters are of confidential/ secret nature.
- 8. The service provider's personnel should be polite, cordial positive and efficient, while handling the assigned work and their actions shall promote goodwill and enhance the image of O/o the Asstt. Director of Income Tax (I&CI), Gurugram. The service provider shall be responsible for any act of indiscipline on the part of persons deployed by the Agency.
- 9. That the persons deputed shall not be below the age of 18 years and they shall not interfere with the duties of the employees of the Asstt. Director of Income Tax (I&CI). Gurugram.

- The Asstt. Director of Income Tax (I&CI), Gurugram may require the service provider to may be incompetent or for his/her/their misconduct or due to any other reason replace such person immediately
- 11. The service provider has to provide Photo identity Cards to the persons deployed by them for carrying out the work. These cards are to be constantly displayed by their persons & their loss reported immediately.
- 12. The service provide shall ensure proper conduct of their persons in office premises and work etc.
- 13. The transportation, food, medical and other statutory requirements in respect of each personnel of the service provider shall be the responsibility of the service provider.
- Working hours for Data Entry Operators would normally be 8 ½ hours per day from 9.30 AM to 6.00 PM during working days including half an hour lunch break in between and exigencies of work, it would be in three shifts of 8 hours each in a day. However, in Saturday, Sunday and other gazette holidays, if required. They may be paid extra wages as per the rates approved.
- That the agency will be wholly and exclusively responsible for payment of wages to the persons engaged by it in compliance of all the statutory obligations under all related legislation as applicable to it from time to time including Minimum Wages Act. (I&CI), Gurugram shall not incur any liability of the Service provider for any expenditure whatsoever on the persons employed by the agency on account of any such statutory obligation. The agency will have to provide particulars of EPF, ESI of its employees with bill submitted by them.
- The service provider will submit the bill, in triplicate in respect of a particular month in the first week of the next month along with copies of receipts towards EPF/ESI/Services Tax deposition for the previous month and copies of attendance register(s). The payment will be released by the third week of the following month after deduction of taxes deductible at source under the laws in force.
- Payments to the service provider would be strictly on certification by the officer with whom the person deployed is attached that his services were satisfactory and his attendance certified as per the bill preferred by the service provider.
- 18. No wage/remuneration will be paid to any person for the days of absence from duty.
- 19. The service provider will have to provide the required number of additional persons for a shorter period also, In case of any exigencies, as per the requirement of this office i.e. Asstt. Director of Income Tax (I&CI), Gurugram.
- 20. The service provider shall provide a substitute well in advance if there is any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the service provider.

- 21. The service provider shall be contactable at all times and message sent by phone/e-mail/whatsapp/Special Messenger from Asstt. Director of Income Tax (I&CI), Gurugram to the service provider shall be acknowledged immediately on receipt, on the same day. The service provider shall strictly observe the instruction issued by the Asstt. Director of Income Tax (I&CI), Gurugram in fulfillment of the contract from time to time.
- 22. The Asstt. Director of Income Tax (I&CI), Gurugram shall not be liable for any loss, damage, theft burglary or robbery of any personal belongings, equipment or vehicles of the personnel of the service provider.
- That the agency on its part and through its own resources shall ensure that the goods, materials and equipment's etc. are not damaged in the process of carrying out the services undertaken by it and shall be responsible for acts of commission and omission on part of its employees, etc. if the Asstt. Director of Income Tax (I&CI), Gurugram suffers any loss or damage on account of negligence, default or theft on the part of the employees/agents of the agency, then the agency shall be liable to reimburse to the Asstt. Director of Income Tax (I&CI), Gurugram for the same. The agency shall keep the Asstt. Director of Income Tax (I&CI), Gurugram fully indemnified against any such loss or damage.
- 24. The Asstt. Director of Income Tax (I&CI), Gurugram shall maintain an attendance registers in respect of the staff deployed by the agency on the basis of which wages/remuneration will be decided in respect of the staff at the approved rates.
- 25. The successful bidder shall furnish a performance Security Deposit of Rs.2,00,000/- in the form of Fixed Deposit Receipt from a commercial bank/bank guarantee from a commercial bank in any acceptable form, safeguarding the interest of the Asstt. Director of Income Tax (I&CI), Gurugram. The security deposit shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the service provider. The security deposit will be forfeited, in case the supply of manpower is delayed beyond the period stipulated by the Asstt. Director of Income Tax (I&CI), Gurugram or non-compliance of theterms of agreement by the service provider or frequent absence from duty/ misconduct on the part of manpower supplied by the Agency.
- 26. The successful bidder will enter into an agreement with this Directorate for supply of suitable and qualified manpower as per requirement of this Directorate on these terms and conditions. The agreement will be valid for a period of twenty one months from the date of contract and shall continue to be in force in the same manner, unless terminated in writing. The charges quoted by the agency (SI.No-3 of Annexure, III) shall be fixed for a period of twenty one months and no request for any change/modification shall be entertained before expiry of the period of twenty one months. However, in case the contact has been given at minimum wages, the minimum wages will be revised so that the same is not less than the minimum wages decided by the Government of Haryana for Gurugram from time to time.
- 27. The service provider shall not assign, transfer, pledge or sub contract the performance of services without the prior written consent of this Directorate.
- 28. The agency shall disburse the monthly salary of the workers before 7th Day of the succeeding month.
- 29. The agreement can be terminated by either party by giving one month's notice in advance. If the agency fails to give one month's notice in writing for termination of the

Agreement then one months wages etc. and any amount due to the agency form the Asstt. Director of Income Tax (I&CI), Gurugram shall be forfeited.

- On the expiry of the agreement as mentioned above, the agency will withdraw all its personnel and clear their accounts by paying them all their legal dues. In case of any dispute on account of the termination of employment or non- employment by the personnel of the agency it shall be the entire responsibility of the agency to pay and settle the same.
- In the event, if any dispute arises touching any of the clauses of the agreement, the matter will be referred to the Asstt. Director of Income Tax (I&CI), Gurugram whose decision shall be binding on both the parties.
- 32. The Agency shall be responsible for faithful compliance of the terms and conditions of this agreement. Failure of it will attract forfeiture of outstanding dues as well as the termination of their contract and getting the work done through some outside agency at their cost and risk, during the remaining period of contract.
